The Government of Nepal (GoN) has allocated TB-SWAp funds to Purbakhola Rural Municipality for Trail Bridge Program and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Sealed Quotation is open to all eligible Nepalese Bidders.
2. The Purbakhola Rural Municipality invites sealed quotation from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

5. Bidding documents may be purchased from the [www.bolpatra.gov.np](http://www.bolpatra.gov.np) by eligible Bidders, on submission a non-refundable fee for bid documents as mentioned in the following table, until the 2077/12/13 before 12:00 am from the first date of publication of this notice.
6. Bids must be submitted through [www.bolpatra.gov.np](http://www.bolpatra.gov.np), on or before **12.00hr, noon** on **2077/12/13** Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at **Purbakhola Rural Municipality, Purbakhola- palpa** on **2077/12/13 and 14.00hr**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a **minimum of 2.5%-3% of bid amount**, which shall be **valid for 15 days** beyond the bid validity period.
8. Bidder should submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np).
