- Purbakhola Rural Municipality, Purbakhola, Palpa invites electronic bids from eligible bidders for the construction of CONSTRUCTION OF 15 BED HOSPITAL under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- 4. Minimum Work experience of similar size and nature: Construction of at least one RCC Framed Structure with Value of Nrs 13,00,000,000.00/-.
- 5. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
